As of the close of business on February 5, 2018, the reporting persons beneficially owned an aggregate of 640,415 shares of the Issuer's Class A Common Stock or 5.0% of the Issuer's Class A Common Stock outstanding.

However, as of the close of business on February 12, 2018, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 440,841 shares of the Issuer's Class A Common Stock (consisting of 365,841 shares of the Issuer's Class A Common Stock and listed options to purchase 75,000 shares of the Issuer's Class A Common Stock) and Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 48,196 shares of the Issuer's Class A Common Stock, which collectively represented 489,037 shares of the Issuer's Class A Common Stock or 3.9% of the Issuer's Class A Common Stock outstanding.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

The foregoing should not be construed in and of itself as an admission by Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets II, as the case may be.

(b) Percent of Class:

As of the close of business on February 12, 2018, Millennium Management, Millennium Group Management and Mr. Englander may be deemed to have beneficially owned 489,037 shares of the Issuer's Class A Common Stock or 3.9% of the Issuer's Class A Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 12,700,986 shares of Class A Common Stock outstanding as of October 30, 2017, as per the Issuer's Form 10-Q dated November 2, 2017.
